

#### **Current Council Members for Re-Election**

## Dr. Mark Chan Peng Chew

Dr Mark Chan Peng Chew is Divisional Chairman, Division of Integrative and Community Care and Senior Consultant in the Department of Geriatric Medicine, Tan Tock Seng Hospital (TTSH). He has his subspecialty interest in dementia and cognitive disorders in the elderly. He is involved in medical education and has appointment of Assistant Professor in the Yong Loo Lin School of Medicine National University Singapore, member of the Geriatric Medicine Residency Advisory Committee and core faculty for Geriatric Medicine Residency program in the National Healthcare Group (NHG).

## Ms. Diane Chen Dan

Experienced Senior Vice President of Financial Planning & Analysis with a demonstrated history of working in the utilities and offshore marine industry. Skilled in Auditing, Accounting, Costs Recovery & Transfer Pricing, Risk & Governance, Digitalisation of financial information and Finance Business Partnering. Strong finance professional graduated from The association of chartered certified accountants with 9 years of professional training in public accounting firm and 14 years of commercial experiences in overseas operation and Singapore mainboard listed company.

# Mr. Chey Chor Wai

Chey Chor Wai is a consultant in the areas of finance, corporate governance, risk management and internal controls. He retired from PricewaterhouseCoopers LLP (PwC) Singapore as an assurance partner, having spent 32 years in the firm. He has worked in the Coopers & Lybrand offices of London, New York and Beijing prior to its merger with Price Waterhouse to form PwC. While in PwC Singapore, he was also a member of the Capital Markets Group, assuming the role of reporting accountants for companies seeking an Initial Public Offering on the Singapore Stock Exchange. He was also concurrently the firm's admin partner from 2001 to 2003.

Chey was a past Independent Director and Chairman of the Audit and Risk Committee (ARC) of Isetan (Singapore) Limited, Courts Asia Limited and Religare Health Trust Trustee Manager Pte Ltd, the trustee manager of the publicly listed Religare Health Trust. He was also a Board member of Info-comm Media Development Authority of Singapore (IMDA) and chaired its ARC. He is still currently serving as a member of the IMDA ARC.

# Dr. Kwa Chong Teck

Dr Kwa Chong Teck began his career as a dental surgeon in the Singapore Armed Forces in 1979. By 1991, when he completed his engagement in the Singapore Armed Forces, Dr Kwa headed the General Staff Branch of its Medical Services and was concurrently the Division Medical Officer of the 3rd Singapore Division.

Between 1982 and 1987, Dr Kwa trained in oral pathology at the University of London's Institute of Dental Surgery at the Eastman Dental Hospital. He also trained at the regional maxillofacial surgery unit at Mount Vernon Hospital in north-west London. He earned the Master of Science in Oral Pathology of the University of London in 1983 and the Fellowship in Dental Surgery of the Royal College of Surgeons of Edinburgh in 1985. He completed the 160th Advanced Management Programme at the Harvard Business School in 2001 and was admitted a Fellow of the Academy of Medicine Singapore in 2004.

In 1991, Dr Kwa transferred to the Ministry of Health to help plan a new National Dental Centre for Singapore. He was the Centre's founding Executive Director, serving from 1995 to 2014.

From 2004 to 2017, Dr Kwa was the founding Executive Director of the SingHealth Foundation. The Foundation funded healthcare-related research and education causes, pioneering treatment regimes and support for needy patients.

Dr Kwa is a member of the SingHealth Board of Advisors with duties at the National Dental Centre Singapore, the SingHealth Duke-NUS Disease Centres, the SingHealth Duke-NUS Pathology Academic Clinical Programme and the SingHealth International Collaborations Office. He also serves on the Board of Directors of the Mount Alvernia Hospital, the Governing Council of the Dover Park Hospice and on the Singapore Dental Council's Complaints Panel.

In 2018, Dr Kwa was an inaugural recipient of the University of London's Ivor Kramer Medal of Distinction for his contributions to dentistry and in 2023, he received the Singapore Society of Pathology's Award for his contributions to pathology.

## Mr. Low Chee Wah

Mr Low Chee Wah has over 30 years of working experience with the last 16 years in the real estate industry. He has held various leadership positions, the last being as the Chief Executive Officer of Frasers Property Retail, before his retirement.
