Dover Park Hospice

1. QUORUM

- 1.1 At 10.00 am, there were 14 members physically present at the Annual General Meeting (AGM). DPH had received 3 proxy forms. Total: 17 members.
- 1.2 The Constitution required a minimum of 25 members or $\frac{1}{4}$ of DPH's registered members to be present whichever is lower before the commencement of the AGM. 17 members met the minimum requirement $\frac{1}{4}$ of DPH's registered members of 60.
- 2. Welcome Address by A/Prof. Jeremy Lim, Chairman of the 31st Governing Council
- 2.1 Chairman welcomed members to the AGM and thanked them for their attendance.
- He introduced that Prof. Ho Yew Kee, Honorary Secretary and Ms. Diane Chen Dan, Honorary Treasurer will be speaking in the meeting.
- 3. Resolution 1: Confirmation of the 30th AGM Minutes

Minutes of the 30th Annual General Meeting (AGM) held on 20 August 2022

As there were no amendments to the minutes of the 30th AGM, the minutes were confirmed and accepted.

The motion was put to vote by show of hands. There being no objections or abstentions, the motion was adopted.

Resolution 2: Chairman's report for financial year ended 31 March 2023

- 4. The Chairman's Report for the financial year ended 31 March 2023 had been duly circulated to 4.1 all members and would be taken as read.
- A/Prof Jeremy Lim delivered his Chairman's report. He thanked all members once again for attending the physical AGM.

DPH 30th Anniversary

4.3 Chairman reported that it was a very significant financial year as DPH reached its 30th

4.3.1 Anniversary. DPH celebrated this momentous milestone through the Appreciation Dinner and Sunflower Charity Concert.

Acknowledgement of our staff, volunteers and supporters

4.4

Chairman shared that it had been difficult times for everyone individually, organizationally and societally. He expressed his special thanks and appreciation to all staff, volunteers and supporters.

Move to New Integrated Care Hub (ICH)

4.5

Chairman updated that the move to the new ICH building would bring DPH opportunities to
4.5.1 advance care programmes that DPH currently run, as well as to encourage the introduction of
newer ones. As DPH looked ahead to the future, DPH would expect to receive more non-cancer
patients who would need the care to leave with the dignity that they deserve.

Welcome New CEO

4.6

Chairman welcomed and introduced DPH's new CEO, Dr Liew Li Lian. As a young medical officer, she had been referring patients to Dover Park Hospice. She was part of the team together with Dr. Angel Lee and Dr. Wu Huei Yaw who brought Respecting Choices, DPH first Advance Care Plan framework to Singapore, and started Project CARE whose offices were on the third floor of the current building. Later, she was part of the planning team which won approval to build the Integrated Care Hub (ICH).

As DPH's new CEO, it will be Dr. Li Lian's job to lead Dover Park Hospice's growth into a national partner that can support the palliative care needs of at least 1 million residents of Central Singapore. There is no better time to be at Dover Park Hospice with the recent announcement of the new National Strategy for Palliative Care by Health Minister, Ong Ye Kung, naming DPH as one of three key partners to spread palliative care beyond hospital walls.

Finance & Operations


4.7

Chairman highlighted that the fiscal position was currently healthy. However, the needs were 4.7.1 growing rapidly and to keep in mind of the finances moving forward. As DPH was moving to the Integrated Care Hub (ICH), the beds would be doubled; the expansion of Home Hospice and use of technology. He shared that the details will be reported under the Audited Financial Statements.

4.8 Fundraising

- 4.8.1 Chairman thanked the Fundraising team especially Dr. Kwa Chong Teck and Dr. Karen Soh who were the co-chairs of the Fundraising Committee.
- 4.8.2 DPH's Sunflower Charity Dinner held on Saturday, 19 August 2023 at the Ritz Carlton had raised more than a million dollars. Special thanks to the generous and supportive donors.

- 4.9 The meeting accepted the Chairman's report.

- 4.10 The motion was put to vote by show of hands. There being no objections or abstentions, the motion was adopted.
- 5. Resolution 3: Audited Financial Statements for FY2022/2023
- 5.1 Ms. Diane Chen Dan, Honorary Treasurer presented the Audited Financial Statements for the year ended 31 March 2023.
- 5.2 Summarised Income & Expenditure
- For the financial year ended 31 March 2023, DPH reported a Total Operating Income of \$4.64 million which was 17% higher than FY 2022. This was mainly contributed by the patient fees of \$4.33 million. The higher patient fees was due to the Inpatient Hospice Palliative Care Services (IHPCS) which enabled DPH to claim for Medishield.
- 5.2.2 The Total Operating Expenditure of \$19.07 million was about 11% higher than FY 2022.
- 5.2.3 The Operating Deficit before grant was amounted to \$14.43 million. This deficit was funded by several sources of income. The government subvention and grants were the main source of income of \$12.87 million.
- The second source of income was the Net Investment Income of about \$833K which was slightly higher than FY 2022. The third source of income came from the Net Fundraising and Voluntary Income of \$2.56 million. Despite the economic climate, we were privileged to continue to benefit from generous and supportive donors.
- 5.2.5 This resulted to a net surplus of \$1.84 million before investment gains and losses. This was 27% lower than FY 2022.
- In FY 2023, there was a net loss from the investment activities of \$1.15 million. This was 31% lower than FY 2022.
- 5.2.7 In conclusion, DPH reported a net surplus of \$686K in FY 2023.
- 5.3 FY 2023: Total Income for the Year



- 5.4 Breakdown of Charitable and Governance Activities
- 5.4.1 Included in the Charitable and Governance activities were mainly the staff and related costs of \$15.80 million which was 15% higher than FY 2022.
- 5.5 <u>Fundraising Efficiency Ratio (FER)</u>
- 5.5.1 The Fundraising Efficiency Ratio (FER) for the year was 19% in FY 2023 as compared to 16% in FY 2022. This was within the NCSS fundraising efficiency ratio of 30:70 ruling.
- 5.6 Reserve Ratio (RR)
- 5.6.1 The Hospice's Reserve Ratio (RR) was reported at 1.16 in FY 2023 as compared to 1.23 in FY 2022. In terms of the number of months, the reserve would be able to last about 14 months should all income and funding ceased and fixed operating expenditure continued to be incurred.

End of Audited Financial Statements

5.7 The motion to accept and approve the Audited Financial Statements was put to the members.

- 6.1 Chairman proposed that KMPG LLP be appointed as external auditors for Dover Park Hospice for the financial year ending 31 March 2024, and put the motion to vote.
